Note that, if you choose not to mail your proxy, it may be misplaced, lost, destroyed, or intentionally withheld by the person to whom you gave it.
- 4. A proxy may be revoked in writing or may be superseded by a later proxy to another person.
- 5. A proxy is effective only for the specific meeting for which it was originally given, as the meeting may lawfully be adjourned and reconvened from time to time, and automatically expires 90 days after the date of the meeting for which it was originally given.
