Tony King, President, reported on projects for 2019:

- 2) Four Fire Hydrants replaced.
- 3) Nest A/C monitor installed in the Game Room.
- 4) Clubhouse flat roof replaced.
- 5) Backflow Preventer installed on the Dock.

### Tom Edwards, Treasurer:

Reports were given on liquid cash & C.D.s totaling \$555,400+ and Reserves totaling \$491,881 with operating capital at \$129,500 to cover insurance & fire hydrant replacements. Interest rates were increased on the oldest C.D from 1.5% to 2.02%; and the second C.D. of \$151,000 interest rate of 1.75% increased by 25%.

## **Chip Bellows, Director at Large:**

The Landscape Committee has a short planting list of flowers and photos for the residents to choose from, now available in the office and on the website. Mulch has been completed in most public areas and at condos 8,7,6,4, & 5; and will be put down around the remaining condos & clubhouse after completion of the painting in 2019. Beginning 2020, only Brown Cypress mulch will be put down in October for all to enjoy.

Plant trimming is scheduled for Palms in May-June, regular trimming is done quarterly (no work order needed) and bushes recommended to be trimmed twice a year.
