Watson Management:

We believe that a major problem needs to be addressed.

Bldg. 13 - 108 has had a stored, covered corvette in a free spot on the property for almost a year

Bldg. 13 -107 has a Suburban stored by the dumpters

Bldg. 12 -106 has a vehicle stored (He alternates his vehicles) along side the dumpster

Bldg. 13 -205 ALWAYS parks his work van along side the dumster wall

At any time there are at least 3 vehicles utilizing these spaces that are provided for guests, boats and miscellaneous vehicles looking for parking. There is NO one residing in 13-208 as of this letter. Both Bldg. 12 & 13 require 2 spaces per unit in season as they own two vechiles.

We ask the management company to access the storage of said vehicles, being hidden or ignored by their owners, in the spaces NOT ASIGNED to their UNIT. STORAGE of such vechicles should require a fine and be told to store them OFF of the property.

Re: Parking & Vehicle Restrictions Rules & Regulations V111

To answer your concerns regarding stored and covered vehicles, please refer to the attached Rules and Regulations V111 that outlines the specific concerns that you mentioned.

R&R V111 - 3. states if a resident has a second passenger vehicle, it shall be parked in an unnumbered guest parking space. Since there is not sufficient space provided for a guest space for each unit, extra spaces are available by the maintenance area for the resident's second vehicle - covered or not.

Some residents have allowed the blank spaces in front of their building to be used by their neighbor due to their disability or illness and parked elsewhere.

Note: The spaces are now Blank and not marked "Guest".

The spaces by the maintenance area are only available for boats, trailers or u-hauls upon Board approval for a couple of days for cleaning, maintenance or moving in, not as extra parking spaces for these vehicles.
